- All of your verification forms require a hand-written signature. This can be completed by printing the document and signing with a pen or by using a mouse or stylus on the online document.
- All documents should be uploaded to the financial aid portal for data security. Email is not a secure method for transmitting personal information.

## **Financial Information:**

As part of federal student aid eligibility, contributors are required to consent and approve the sharing and import of information from the IRS directly to the FAFSA form. You and your family may also be asked to provide income documents such as W-2's, a signed copy of your 2022 tax return or a tax transcript.
